

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, limited the congregation of groups of people.

Swartz Creek Youth Football/Cheer/Poms has put in place preventative measures to reduce the spread of COVID-19; however, we cannot guarantee that you, your child(ren), or family members who visit our facility will not become infected with COVID-19. Further, attending Swartz Creek Youth Football/Cheer/Poms could increase your risk, your child(ren)'s risk, and your family's risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), my family, and I may be exposed to or infected by COVID-19 by attending Swartz Creek Youth Football/Cheer/Poms and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Swartz Creek Football/Cheer/Poms may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Swartz Creek Football/Cheer/Poms, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), family or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance and participation in Swartz Creek Football/Cheer/Poms programming. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Swartz Creek Youth Football/Cheer/Poms, its volunteers and representatives, if/whether a COVID-19 infection occurs before, during, or after participation in any of our programs.

I also understand the refund policy if Swartz Creek Youth Football/Cheer/Poms season is cancelled due to COVID-19. The below refunds will be issued if the 2021 season is cancelled prior to August 1, 2021. (These prices reflect the purchase of jerseys/hoodies/leggings/uniforms that you will receive if the 2021 season is cancelled.)
